During the presentation, Dr. Durkin and Dr. DeFalco also added:

- The Evidence-Based Teaching and Learning (EBTL) model at NBHS was empowering students to learn more critically.
- Several of the long-neglected school facilities were getting new boilers and windows.
- Upgrading of technology is taking place with a focus on preparing the access of on-line PARCC testing for Grades 4 & 8 for this school year. Results will be available in a timelier manner, giving administrators the opportunity to adapt more quickly to plan instruction. Other grade levels will be added in the coming years.
- The Plan Manager (DMC) will no longer work with NBPS. The DESE has determined that the district can manage this work and we can continue to work with a DESE monitor only.
- The Accelerated Learning Program at Keith is currently in the pilot stage and will hopefully be replicated at the other middle schools next school year.
- The STAR Assessment Tool is being used in 11 schools. It is computer based and may replace Galileo within the district.
- New standards are being worked on in regard to the science curriculum.

Mr. O'Leary stated that on average, 30-40% has been expended in general expense and schools have the majority of their funds spent due to the purchase of supplies.
