Kendra Vieira, Alternate Student Representative, was in attendance.

VOTED UNANIMOUSLY, on a motion by Mr. Nobrega and seconded by Mrs. Ussach, to take the School Choice participation for 11/12 SY item off the table.

Superintendent Francis informed the Committee that in the case of Circuit Breaker, that the receiving school district would be receiving allocation for each student. In addition, Dr. Francis indicated that additional reimbursements based on types of services provided to special education students would be made on a case-by-case basis. Mrs. Larkin recently consulted with Attorney Catherine Lyons who looked into this program at districts as large as ours. However, most districts did not provide the complex and vast services to special needs students as we do. Atty. Lyons cautioned that School Choice participation may cause an influx of special education students to our District.

VOTED UANIMOUSLY, on a motion by Dr. Fletcher and seconded by Mrs. Ussach, to table School Choice participation for SY 11/12 to the next meeting.

At this time, Superintendent Francis explained the budget documents each member had received in their packets. Documents received were "Positions through Attrition", "Three-Year Transportation Comparison" and updated "General Expense Line Items – Reduced by 19%".

VOTED UNANIMOUSLY, on a motion by Dr. Fletcher and seconded by Mrs. Ussach, to cut the School Committee expenses to \$0.

After a discussion on the updated budget, Mrs. Ussach made a motion, seconded by Dr. Fletcher, to adopt the revised General Expenses budget – reduced by 19% (\$21,247,092.18).
